



CSJ Report - New Orleans Mayor Apologizes for 1891 Lynching Sister Marjorie Focarazzo

LaToya Cantrell, Mayor of New Orleans embraced the idea of apologizing for the atrocity that happened to eleven Italians in 1891 when approached by the Commission for Social Justice (CSJ). Vincenzo Pasquantonio, Human Relations Commission head, to act as liaison. Michael Santo of the Order of Sons and Daughters of Italy in America stated, "This has been a long-standing wound."

What lead up to the March 14, 1891 lynching was the acquittal of six of the nine men and a mistrial declared for the remaining three who had been indicted for their alleged role in the murder of police chief David Hennessy. There had been innuendos and rumors of an Italian network of criminals who had been responsible for the killing of the police chief. There was further belief the jury had been bribed, and a mob broke into the jail where the men were held and eleven prisoners were killed, mostly by shooting. The mob were in the thousands, including some very prominent and influential citizens, who gathered near the statue of Henry Clay. The press, both in the north and the south, was unified in its endorsements of the lynching and amplified the coverage as congratulatory. Those responsible for the lynching were never charged. Correspondence between the US, state officials, and the Italian government showed the lynching happened in agreement and collaboration with New Orleans officials.

One response to the lynching was the closing of the Italian embassy in the US, followed by he US embassy closing in Italy. The cutting of diplomatic ties sparked rumors of war, increased anti-Italian sentiment, restrictions on immigration, the term *Mafia* was now heard more and more in reference to Italians, and the stereotype of the *Italian Mafioso* became established in American culture.

During the 1800's and early 1900's, the American press was vastly racist and supported lynching's, which was considered a tradition the press accepted and defended violence against racial minorities under the guise of being lawful. Revenge was a respected value, and it was believed the murder of Police Chief Hennessy was being avenged. It just made sense to praise the lynch mob, which was honorable because it reflected their values.

Anti-Italian sentiment was growing throughout the US in the late 19th-century. They were immigrating in large numbers because of poor conditions and were able to fill the shortage of cheap labor as a result of the end of slavery. Recruiters were hired to bring Italians to southern Louisiana to work the sugar plantations. Many settled in the French Quarter of New Orleans. The mayor of New Orleans during this time of migration expressed common anti-Italian prejudice.

On April 12th, the city of New Orleans and Mayor Cantrell will present a proclamation apologizing for the city's involvement at the American Italian Cultural Center.

City of New Orleans to Issue Proclamation of Apology for Largest Lynching in United States History

Washington, D.C., March 25, 2019 – The City of New Orleans will be issuing an official Proclamation of Apology on April 12, 2019, regarding the largest lynching in United States history.

Following the murder of New Orleans Police Chief David Hennessy on October 16, 1890, several Italian immigrants were arrested without just cause. Nine of the 19 men who were indicted went to trial, which resulted in six acquittals and three mistrials (because the jurors couldn't agree on a verdict).

In reaction to this, on March 14, 1891, a mob formed outside of Parish Prison. The rioters broke inside and dragged 11 Italian immigrants out of the prison. Those 11 Italians were hung, shot, and/or clubbed to death in the city streets—marking the largest lynching in United States history. Five of those who were killed had not even been tried in court. Eight of the wrongfully imprisoned Italian immigrants survived the lynch mob by managing to hide in the prison itself. Afterward, the charges against them were dropped, and they were set free. In the end, 11 Italian immigrants were lynched for a murder that was never solved, and those who were guilty of the lynching were never arrested and brought to justice.
