Ferrero-The Story of a Family

Ferrero, most closely associated with Nutella, Ferrero Rocher, Tic Tacs, and Kinder, competed with Hershey in buying the Nestle Corporation who markets Butterfinger, Baby Ruth, 100 Grand, Raisinets, Wonka and Nestle Crunch. Ferrero won and will thus become the third largest chocolate company in both the US and the world. Ferrero will buy manufacturing plants in Illinois, there will be no expected layoffs, and corporate offices in California, Illinois, and New Jersey will remain open.

The history of the Ferrero Group is a story of success in its third generation, in which the development of a multinational company perfectly combines with the past, present and future of a tenacious Piedmontese family. We have to return to the '40s to discover the roots of this success. These were the years when Piera and Pietro, Michele's parents, transformed a pastry shop into a factory. The Ferrero' Family was the first Italian manufacturer after World War II to open production sites and offices abroad in the confectionary sector, turning the Company into a truly international Group. These first and decisive steps forward were thanks to the products "invented" by Pietro Ferrero and his son Michele, who was then very young. Another key to success was the effective sales network organized by Giovanni, Pietro's brother, who died in 1949.

Following the success of the company in Italy, Michele Ferrero decided to start producing also abroad. In 1956 a large plant in Germany was inaugurated and a short time later a plant in France. It was the prelude to a rapid expansion of Ferrero in Europe, with the establishment of commercial offices and production centers in Belgium, The Netherlands, Austria, Switzerland, Sweden, United Kingdom, Ireland and Spain. In the following decades Ferrero becomes global, with companies and plants in North and South America, South East Asia, Eastern Europe, Africa, Australia; and, more recently, in Turkey, Mexico and China.

Ferrero is now steadily ranked among the first companies in the world for its reputation. Certainly, this is due also to the social responsibility initiatives of the Group. These are summarized in Ferrero's CSR strategy, which is focused on the highest quality and innovation, transparent communication, the care for people that have made and are still making the Group's history, the support of local communities, the promotion of active lifestyles amongst young people as well as its strong engagement towards sustainable agricultural practices and the protection of the environment. 2018 Grand Lodge Scholarship

Since the beginning of the scholarship program for high school seniors and graduate studies, the New York Grand Lodge has distributed approximately \$1,000,000 in award dollars to deserving students. Scholarships were established by Filial Lodges, Districts, and individuals and subsidized by the Grand Lodge Foundation.

In 2017, 137 scholarships and six grants were awarded.

A total of 124 District Scholarships, 14 Statewide Undergraduate and Graduate awards, and six grants will be distributed to 74 students on Saturday, June 9th at a special program at the Tappan Zee High School, Orangeburg, NY. Every award recipient will become a Student-Member-At-Large member of the Order.

Applications for senior high students will be mailed to counselors outlining the requirements for students in Monroe County. Additional applications can be found on the OSIA web page at www.nysosia.org or by contacting the District VIII chairperson, Marjorie Focarazzo at 585-749-5346 or by email at MAFocarazzo@gmail.com. The applicant must be a New York State resident and of Italian heritage, but membership to OSIA is not required. An application fee of \$10 must be included. The deadline for submission of all materials is March 31, 2018. The application for the grant can also be found on the OSIA website or by contacting the District VII chairperson.

2018 OSDIA/NYS CSJ La Bella Award

The Order of Sons of Italy and New York State Commission for Social Justice established La Bella Lingua Achievement Award to recognize students excelling in Italian Language courses. The award recipient will receive a \$500 monetary award funded by the New York Grand Lodge Foundation, Inc.

The application will be mailed to foreign language teachers and guidance counselors of those High Schools offering Italian Language courses. Only the most qualified student, with at least three years of Italian Language courses, will be asked to participate. The student will be required to submit the application, official transcript, letter of recommendation, and an essay chosen from the six topics noted on the application. The deadline for submission of all materials is April 1, 2018.

The Assassination of Gianni Versace Sister Marjorie Focarazzo

Gianni Maria Versace was born December 2, 1946 in Reggio Calabria and found the international fashion house Versace. He was strongly influenced by ancient Greek History which was part of the landscape in which he grew up. At a young age, he began an apprenticeship with his mother's sewing business. He moved to Milan at 26 years of age to work in fashion design.

In the 1970's he developed successful youthful lines: Byblos and Complice, which helped in creating his first signature collection for women at the Palazzo della Permanente Art Museum of Milan. He opened his first boutique in Milan's Via della Spiga in 1978.

Versace met his partner, a model, Antonio D'Amico, in 1978, a relationship that lasted until his murder in 1978. During their years together, D'Amico worked for Versace's company as a designer and became the head designer for Istante and Versus Sport.

Versace was shot and killed on the steps of his mansion in Miami Beach at the age of 50 on the morning of July 15, 1997. Andrew Cunanan was charged with the murder but committed suicide eight days later. The murder was a crime that shocked the world. Cunanan instantly became the center of world-wide attention. He considered himself a gigolo, but was down on his luck at 27. It was reported he had a genius-level IQ, was a voracious reader, and coveted the lifestyles of the rich and famous. He craved the limelight and aspired to the top, using his charm or falsehood, and in the end he reached an exclusive highpoint that got him to where he wanted to be. Sadly to say, America's most wanted fugitive. The FBI not only wanted to question him about Versace's murder, but also four others that took place earlier in the spring. Versace's longtime companion, Antonio D'Amico, was able to identify Cunanan as the killer who walked away from the mansion. It became clear Cunanan rarely told or faced the truth about himself. He claimed to have dropped out of Yale and transferred to Bennington, but the truth is, he graduated from La Jolla's private Bishop's School. He hung around very intelligent and talented people to establish his pattern as a con artist, lying, being an authoritative on art, being witty, boasting, and entertaining enough to live well without having to work. He claimed to be the son of an Israeli millionaire, and at other times, a Fifth Avenue aristocrat. He never told the truth. He never mentioned his father was accused of embezzling more than \$100,000 who abandoned his wife and four children in 1988. His friends indulged him in his stories.

It is apparent that Versace and Cunanan had met only once, years prior in San Francisco, but Cunanan considered them to be friends. The FBI finally deduced the motive for the assassination was that Cunanan considered Versace to be wealthy, the high-profile homosexual success story Cunanan was never going to be. This was the only way he was going to be famous.

This responsibility is made into reality through Ferrero's nutritional strategy, ongoing innovation, the quality and freshness of its products, food safety and responsible and transparent communication. In addition, Ferrero shows a constant interest in the lives of its current employees and former employees and people living in the communities in which it operates. This commitment is also demonstrated through the activities of the Ferrero Foundation and the Michele Ferrero Entrepreneurial Project, active in Africa and Asia. The Group also continues its commitment to the promotion of active lifestyles by addressing young people and their families through the global Kinder+Sport "Joy of moving" program.

Monitoring and improving the impact of its activities throughout the entire supply chain is a priority for the Ferrero Group, which it addresses by ensuring that its main raw materials are responsibly sourced.
